178-21 RESOLUTION OF INTENT TO TERMINATE THE EMPLOYMENT OF ELLEN BIRCHWELL PURSUANT TO OHIO REVISED CODE 3319.30 AND 3319.36 AND ARTICLE XXXVII OF THE COLLECTIVE BARGAINING AGREEMENT

WHEREAS, the Board of Education of the New Miami Local School District ("Board") has received a recommendation to terminate the employment contract of Ellen Birchwell for reasons set forth herein, pursuant to Ohio Revised Code 3319.16 and Article XXXVII of the collective bargaining agreement between the Board and the New Miami Education Association; and

WHEREAS, Mrs. Birchwell is employed by the Board under a teaching contract; and

WHEREAS, Mrs. Birchwell as assigned to the position of foreign language teacher and held a five year professional high school license to teach Spanish that expired on June 30, 2021 that permitted her to serve in her assigned position; and

RECORD OF PROCEEDINGS

WHEREAS, Mrs. Birchwell was required under Ohio law, the collective bargaining agreement, and her employment contract to secure appropriate licensure to her assigned position prior to the commencement of the 2021/2022 school year; and

WHEREAS, Mrs. Birchwell was aware of the need to maintain appropriate licensure, and admits that she procrastinated and failed to do so by the first workday of the 2021/2022 school year and has not as of the date of this resolution applied for or secured an appropriate license; and

WHEREAS, Mrs. Birchwell thus fails to hold the required license for her assigned position for the 2021/2022 school year and the Board is prohibited under Ohio law from allowing Mrs. Birchwell to serve in her foreign language teacher position or any other regular teaching position; and

WHEREAS, Mrs. Birchwell was afforded the opportunity to appear before the Superintendent and supervising administrators in multiple meetings to discuss her failure to timely secure appropriate licensure; and

WHEREAS, Mrs. Birchwell appeared with union representation during at least one of these meetings, and union representation was also engaged through other forms of communication including with the Board's legal counsel; and

WHEREAS, the Superintendent recommends that the Board terminate Mrs. Birchwell's employment contract pursuant to Ohio Revised Code 3319.16 and Article XXXVII of the collective bargaining agreement for the reasons set forth herein; and

WHEREAS, the Board believes that Mrs. Birchwell's failure to timely secure an appropriate credential constitutes "good and just cause" for the termination of her employment pursuant to Ohio Revised Code in accordance with the collective bargaining agreement. Moreover, the Board believes that her continued employment as a teacher is prohibited as a matter of law and that there is no discretion vested in the Board on this matter. The Board has received evidence which specifically supports and documents the reasons for the recommendation to terminate and Mrs. Birchwell has had an opportunity to respond to said evidence and allegations.

THEREFORE, BE IT RESOLVED that Ellen Birchwell is hereby terminated as an employee of the Board pursuant to Ohio Revised Code 3319.16 and Article XXXVII of the collective bargaining agreement for "good and just cause" for the reasons set forth herein, including her failure to timely secure an appropriate licensure for her assigned position as required by Ohio law, the collective bargaining agreement, and her employment contract.

BE IT FURTHER RESOLVED, that the Treasurer is hereby authorized and directed to provide Mrs. Birchwell with written notice, signed by the Treasurer, of the Board of Education's intention to consider termination of her employment contract, pursuant to Ohio Revised Code 3319.16 and Article XXXVII of the collective bargaining agreement for good and just cause.

It is found and determined that all formal actions of this Board concerning to the adoption of this Resolution were adopted in an open meeting of this Board, and all deliberations of this Board and any of its committees that resulted in such formal actions were adopted in meetings open to the public, in compliance with all applicable requirements of the Ohio Revised Code.

Mrs. Carbary moved and Mr. Chapman seconded the motion that the above Resolution be adopted.
